

Pornography and Sexual Violence against Women

These attitudes and beliefs can increase sexual violence against women.^[1] Studies have shown a correlation between the consumption of sexually explicit material and the perpetration of sexual violence.^[7] Men who regularly consume pornography are more likely to hold negative attitudes toward women and to engage in sexual harassment, sexual assault, and other forms of sexual violence.^[2] Moreover, the themes of violence, domination, and degradation often depicted in pornography can desensitize men to violence and can contribute to a distorted view of sexuality, making them more likely to engage in acts of sexual violence.^[1]

It is important to note that while pornography can contribute to sexual violence against women, it is not the sole cause of this issue. [3] Sexual violence against women is a complex issue with multiple root causes, including societal attitudes and beliefs about gender and sexuality, as well as individual experiences and relationships. [1] However, normalizing harmful attitudes and behaviors towards women in pornography can significantly perpetuate these attitudes and increase the risk of sexual violence against women. [2]
